**AN ORDINANCE AUTHORIZING THE
VILLAGE ADMINISTRATOR TO ADVERTISE AND SELL SURPLUS AND
UNUSED VILLAGE PROPERTY, TO WIT: THREE MOTOR VEHICLES
PREVIOUSLY USED BY THE POLICE DEPARTMENT, AND THE
DECLARATION OF AN EMERGENCY**

WHEREAS, the Village owns three (3) surplus and unused motor vehicles previously utilized by the Village Police Department, which property needs to be sold at public sale; and,


WHEREAS, the sale of said property will add to the general fund of the Village, be available to the Village Police Department for purchase of new equipment, and eliminate storage issues; and,

WHEREAS, this legislation needs to be adopted on an emergency basis due to the need for new equipment by the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF
THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO,
THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: The Village Administrator is hereby authorized to advertise and sale, at a public sale, surplus and unused miscellaneous Village property, to wit: three (3) motor vehicles previously used by the Police Department. Copies of the titles to the motor vehicles to be sold are attached hereto and incorporated herein.


SECTION 2: For the reasons noted in the preamble, this ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, morals, and welfare of the citizens of Baltimore, Ohio. This ordinance shall become effective upon its passage by Council.
