**A RESOLUTION ACCEPTING THE AMOUNTS  
AND RATES AS DETERMINED BY THE FAIRFIELD  
COUNTY BUDGET COMMISSION AND  
AUTHORIZING THE NECESSARY TAX LEVIES  
AND CERTIFYING THEM TO THE COUNTY AUDITOR  
AND THE DECLARATION OF AN EMERGENCY**

WHEREAS, this Council, in accordance with the provisions of law, has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2019; and,

WHEREAS, the Budget Commission of Fairfield County, Ohio has certified its action thereon to this Council, together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill limitation; and,

WHEREAS, this resolution needs to be certified to the Auditor in the very near future and will need to be passed on an emergency basis;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF  
THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO,  
THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

SECTION 2: That there be and is hereby levied on the tax duplicate of the Village of Baltimore the rate of each tax necessary to be levied within and without the ten mill limitation as shown on the attached SCHEDULE A.

SECTION 3: That the Fiscal Officer of the Village of Baltimore be and is hereby directed to certify a copy of this Resolution to the Auditor of Fairfield County.

SECTION 4: For the reasons noted in the preamble, this resolution is deemed to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and general welfare of the citizens of Baltimore, Ohio. Therefore, this resolution shall become effective immediately upon its passage by Council.
