AN ORDINANCE AMENDING CHAPTER 1024 OF THE BALTIMORE CODIFIED ORDINANCES (SEWER AND WATER CHARGES)

WHEREAS, the Village desires to amend the Water and Sewer Fee Schedule as set forth in Chapter 1024.05 of the Codified Ordinances in order to update its tap fees and capacity fees; and,

WHEREAS, Service Committee has reviewed the proposed amendment and recommends adoption of the same;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL
OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY,
OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

SECTION 1: That Chapter 1024.05 of the Baltimore Codified Ordinances (Sewer and Water Charges - Water and Sewer Tap Charges and Related Fees), which currently reads in relevant part as follows:

“1024.05 WATER AND SEWER TAP CHARGES AND RELATED FEES.

(c) Fee Schedule.

400 (Residential only)	3/4 inch	\$2,500	\$3,500
1,000 (Minimum commercial)	1 inch	\$5,000	\$7,000

5,000	2 inch	\$15,000	\$21,000
30,000	4 inch	\$45,000	\$63,000
90,000	6 inch	\$67,500	\$94,500
200,000	8 inch	\$90,000	\$126,000”

is hereby amended and shall henceforth read as follows:

“1024.05 WATER AND SEWER TAP CHARGES AND RELATED FEES.

SECTION 2: All other provisions of Chapter 1024.05, including but not being limited to Low Pressure Grinder Pump Fees and Fire Tap Fees, not specifically amended herein, shall remain in full force and effect.

SECTION 3: This ordinance shall become effective at the earliest period authorized by law.
