Ordinance No. 2020-08

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH BIRD+BULL ENGINEERS & SURVEYORS FOR ENGINEERING SERVICES FOR THE 2020 ROADWAY RESURFACING PROJECT, AND THE DECLARATION OF AN EMERGENCY

WHEREAS, the Village of Baltimore requires specific engineering services (bidding/construction/post-construction phase services; detailed/final design services) for the 2020 Roadway Resurfacing Project [along Holder Road from East Market Street to the Village corporation limit] ("the Project"); and,

WHEREAS, Bird+Bull Engineers & Surveyors has the necessary qualifications to provide such specific engineering services to the Village for the Project; and,

WHEREAS, Service Committee has reviewed the matter and recommends approval of an agreement between the Village and Bird+Bull Engineers & Surveyors for the provision of specific engineering services for the Project; and,

WHEREAS, this legislation needs to be approved on an emergency basis in order for both the engineering services and bidding process to be completed in a timely fashion, and for the project to be completed in fair weather months;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO, THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: The Village Administrator is hereby authorized and directed to enter into an agreement with Bird+Bull Engineers & Surveyors in order to provide engineering services to the Village for the 2020 Roadway Resurfacing Project. The company shall be paid in accordance with its fixed fee estimate previously submitted to the Village, in an amount not exceeding \$12,000.00.

SECTION 2: For the reasons noted in the preamble, this Ordinance is declared to be an emergency measure necessary for the health, safety and general welfare of the community. Therefore, this ordinance shall become effective immediately upon its passage by Council.
