A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO SUBMIT A GRANT APPLICATION AND TO PROVIDE ALL INFORMATION AND DOCUMENTATION REQUIRED TO BECOME ELIGIBLE FOR POSSIBLE FUNDING ASSISTANCE THROUGH THE OHIO DEPARTMENT OF NATURAL RESOURCES NATURE-WORKS GRANT PROGRAM, AND THE DECLARATION OF AN EMERGENCY

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources, administers financial assistance to municipalities for the NatureWorks Grant Program; and

WHEREAS, the Village of Baltimore desires to be considered for financial assistance through the ODNR for the NatureWorks Grant Program; and,

WHEREAS, this legislation needs to be passed on an emergency basis due to the absolute grant application deadline of June 1, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO, THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: That the Village of Baltimore approves the filing of an application for financial assistance through the Ohio Department of Natural Resources for the NatureWorks Grant Program.

SECTION 2: That the Village Administrator is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

SECTION 3: As the grant requires contributing funds from the Village, with the total project cost not to exceed \$21,000.00, that the Village of Baltimore hereby agrees to obligate the funds required to satisfactorily complete the proposed project, the Village's share of contributing funds being approximately \$6,000.00.

SECTION 4: That this resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, morals, and welfare, as the funding application absolute deadline is June 1, 2017. Therefore, this resolution shall be in full force and effect immediately upon its adoption.
