PREVIOUSLY USED BY THE UTILITIES DEPARTMENT**


WHEREAS, the Village owns two (2) surplus and unused motor vehicles previously utilized by the Village Utilities Department, which property needs to be sold at public sale; and,

WHEREAS, the sale of said property will add to the general fund of the Village, be available to the Village for purchase of new equipment, and eliminate storage issues; and,

SECTION 1: The Village Administrator is hereby authorized to advertise and sale, at a public sale, surplus and unused miscellaneous Village property, to wit: two (2) motor vehicles previously used by the Utilities Department, consisting of a 2001 Chevrolet Pickup Truck, Model S14; and a 2000 Chevrolet Pickup Truck, Model S14. Copies of the titles to the motor vehicles to be sold are attached hereto and incorporated herein.

SECTION 2: This ordinance shall become effective at the earliest period authorized by law.
