AN ORDINANCE TO AMEND CHAPTER 1042 (CEMETERIES) OF THE BALTIMORE CODIFIED ORDINANCES, IN ORDER TO UPDATE VARIOUS FEES

WHEREAS, the Village desires to amend Chapter 1042 (Cemeteries) of the Baltimore Codified Ordinances in order to update various fees; and,

WHEREAS, Service Committee has reviewed the proposed amendment and recommends adoption of the same;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF
THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO,
A MAJORITY OF ITS MEMBERS CONCURRING:

SECTION 1: That Chapter 1042.07 (Cemeteries - Fees) of the Baltimore Codified Ordinances, which currently reads as follows:

“1042.07 FEES.

(a) The following are the established Village cemetery fees.

Graves	\$400
Transfer charge	20
Interment and perpetual care	400
Weekends, after hours and Village holidays	550
Cremation and perpetual care	175
Weekends, after hours and Village holidays	350
Entombment	250
Weekends, after hours and Village holidays	400
Disinterment	600
Weekends, after hours and Village holidays”	750

is hereby amended to read as follows:

“1042.07 FEES.

(a) The following are the established Village cemetery fees.

	<u>Resident</u>	<u>Non-Resident</u>
- Single graves:	\$400*	\$850
- Deed transfer:	30	30
- Weekday interment (opening and closing before 3:30 p.m.):	600	800
- Overtime rate (additional fee) for interment on weekends, Village holidays and after 3:30 p.m. on weekdays:	400	400

- Cremation interment on weekdays (before 3:30 p.m.):	250	250
- Cremation interment on weekends, Village holidays and after 3:30 p.m. on weekdays:	350	350
- Entombment (before 3:30 p.m. on weekdays):	250	250
- Entombment on weekends, Village holidays and after 3:30 p.m. on weekdays:	400	400
- Disinterment:	1,000	1,600

*Non-transferable grave lots owned by Village residents must be sold to the Village at the original purchase price of the lots.

Determining legal residency.


- (1) Determination: Prior to the approval of the above "Resident" rates, the Village Administrator shall make a reasonable attempt to determine whether the purchaser/deceased was a legal resident of the Village.
- (2) Definitions: "Legal Residency" means a physical presence in a particular location, coupled with the present intent to make that place a permanent residence for a period of time.
- (3) Nursing Homes and Assisted Living Facilities: In cases where the purchaser/deceased was living in a nursing home or assisted living facility located within the Village, legal residency shall mean an intent to make the nursing home or assisted living facility a permanent residence."

SECTION 2: This ordinance shall become effective at the earliest period authorized by law.
