**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR AND FISCAL OFFICER TO CONTRACT WITH KAFFENBARGER TRUCK EQUIPMENT CO. AND PARK NATIONAL BANK FOR THE PURCHASE OF AN ACCESSORY PACKAGE FOR A 2020 FORD F550 SERVICE TRUCK FOR THE SERVICE DEPARTMENT, AND THE DECLARATION OF AN EMERGENCY**

WHEREAS, the Service Department is in need of an accessory package for a new service truck for the efficient operation of its department; and,

WHEREAS, Park National Bank of Baltimore, Ohio, has committed to financing the purchase of the accessory package for the new service truck, pursuant to a commercial loan proposal; and,

WHEREAS, Ohio Revised Code (ORC) Section 735.051 further authorizes the purchase of supplies or materials without formal bidding and advertising in the event of a real and present emergency; and,

WHEREAS, Finance Committee has recommended the purchase, and approved the appropriation of funds for the purchase; and,

WHEREAS, due to the recent failure of operation of the Village's current service truck, and the Village's reliance on a service truck with accessories on a daily basis, a real and present emergency exists for the operation and maintenance of the Service Department, and as a result this ordinance will need to be passed on an emergency basis;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BALTIMORE, FAIRFIELD COUNTY, OHIO, THREE-FOURTH'S (3/4'S) OF ITS MEMBERS CONCURRING:

SECTION 1: The Village Administrator and Fiscal Officer are hereby authorized to enter into a purchase agreement with Kaffenbarger Truck Equipment Co. for the purchase of an accessory package for a new 2020 Ford F550 service truck, for an amount not to exceed \$17,687.00, without competitive bidding or advertising as authorized per Section 735.051 of the Ohio Revised Code. A copy of the purchase proposal from Kaffenbarger Truck Equipment Co. shall be attached hereto and incorporated herein.

SECTION 2: The Village Administrator and Fiscal Officer are hereby authorized to enter into a commercial loan agreement with Park National Bank of Baltimore, Ohio, for the financing of the purchase of the above accessory package, for a loan amount not exceeding \$17,687.00 and an interest rate not exceeding 3.0% APR. A copy of the commercial loan commitment from Park National Bank shall be attached hereto and incorporated herein.

SECTION 3: For the reasons noted in the preamble, this ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, morals, and welfare of the citizens of Baltimore, Ohio. This ordinance shall become effective upon its passage by Council.


